Steering Council of the University of Gjakov "Fehmi Agani", pursuant to article 17 point 3 and 23, of the Provisional Statute of the University, in the meeting held on 04/10/2019, approved this:

**REGULATION ON SCHOLARSHIP AWARD IN THE
UNIVERSITY OF GJAKOVA “FEHMI AGANI”**

Artile 1

General provisions

With this regulation are specified criteria, conditions and procedures for university scholarship award for students of bachelor and master levels in the University “Fehmi Agani” in Gjakova.

Article 2

Financial Resources

1. Material means for university scholarship allocation are provided by:
 - 1.1. Participation for studies (study fees and other administrative payments), in cooperation with MES and Ministry of Finance;
 - 1.2. Payments for commercial services and other services done by the University;
 - 1.3. Donations, gifts and aid;
 - 1.4. Contracts with local, international, public and private bodies for teaching, scientific research, artistic work and consultations;
 - 1.5. Other income in accordance with law in force.



Article 3

Criteria for scholarship award

1. To earn the university scholarship, students of bachelor and master studies shall fulfill these conditions:
 - 1.1. To be regular students of the University "Fehmi Agani" in Gjakova;
 - 1.2. To have passed all the exams of the respective previous year in the September term;
 - 1.3. To have average grade in Bachelor level at least 9.00 (nine) and in Master level 9.50 (nine point fifty).
 - 1.4. Shall not have repeated year of study.
2. For foreign students that are not regular students according to the paragraph 1.1 of this article, Steering Council can decide with a special decision for specific scholarships, after the termination of the procedures of student mobility.

Article 4

Scholarship amount height

The height of university scholarship will be specified from the Steering Council for every academic year with a special decision, dependently from the budget and number of students who fulfill the criteria.

Article 5

"Distinguished Student"

1. University "Fehmi Agani" in Gjakova awards the "Distinguished Student" award and this award belongs to the students of the last year of studies (Bachelor and Master) with average grade 10.00 (ten point zero).
2. If there are no such students, the "Distinguished Student" award can be awarded to the students of last year of studies with average grade not less than 9.5 (nine

- point five) at most 3 students for each faculty (cademic unit).
3. For this award can apply students, with a proposal of respective faculties in consultation with Rector.
 4. The height of "Distinguished student" award is specified by the Steering Council with a special decision.
 5. Certificate for "Distinguished student" is submitted after the closure of September term of the coming year.

7. Article 6

Commission on scholarship allocation

Reviewal of student applications, candidates for university scholarship is done by the commission responsible appointed by the University management, which is composed by 5 (five) members, where 3 (three) are from Rectorate and 2 (two) from Steering Council.

Article 7

Announcement of result

1. Commission on scholarship allocation after the reviewal of candidate applications, tkes the decision for candidates that are scholarship beneficiaries and for those who were refused this right.
2. Decision with the results is published in the official site of the University.
3. Students, beneficiaries of schollarship are informed in written for the height of scholarship amount and other necessary information.

Article 8

The right on complaint

Disatisfied candidates with the decision taken after the publishes result, have the right to complain to the Steering Council in a deadline of 8 days from the day of decision is published.
